- The Baraboo location will be collecting donations for the Sauk County Children's Giving Tree.
 This organization provides a variety of products including Christmas toys, clothing and supplies to children and families in Sauk County.
- The Eau Claire location will be collecting donations for the Christmas is for Children program.
 Choose a Child's tag from our tree and purchase presents for them to open on Christmas. All Children receiving gifts are from the local community. The Child's tag includes a wish list and clothing sizes, for purchases of up to a \$35 value for each child.

- The Marshfield location is collecting funds for the Ronald McDonald House. The Ronald McDonald House reduces the stress and financial burden for families when they must travel far from home to access medical care for their child.

 project. The Taylor County Supportive Housing authority provides those who are homeless with
